Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

However, the Housing Authority is projected to have less than two percent in reserves by the end of the calendar year and is being monitored by HUD for shortfall.</i> • Increase Section 8 vouchers through requests for incremental and/or special needs vouchers – <i>The Housing Authority applied for an incremental increase in VASH and 50 mainstream vouchers in 2019. The Housing Authority was awarded 10 incremental VASH vouchers and 50 mainstream vouchers. In addition, the Housing Authority has since been awarded an additional 15 mainstream vouchers in 2020.</i> • Grow the home ownership program, utilizing Section 8 vouchers, for not less than 10 families – <i>The Housing Authority has developed a home ownership program and is working in connection with development to create home ownership opportunities for its residents.</i> • Continue to house homeless through 100 project-based vouchers with our community partners – <i>The Housing Authority has set aside 100 project-based vouchers for housing homeless throughout Yakima County.</i> • Continue to lease all remaining 93 VASH vouchers in connection with the Veteran’s Affair Office – <i>The Housing Authority has currently leased 68 VASH vouchers and is working with the Veteran’s Affair Office to lease the remaining vouchers.</i> • Lease the five Mainstream vouchers in coordination with the Spokane Housing Authority – <i>The Housing Authority currently is administering 65 mainstream vouchers and the Spokane Housing Authority ported the remaining mainstream vouchers it administered in coordination with the Yakima Housing Authority.</i> • Work with our community partners to establish the Foster Youth Initiative – <i>The Housing Authority created an MOU with its community partners and has currently received four referrals.</i> • Preserve the Family Self-Sufficiency program for at least 125 families on Section 8 – <i>The Housing Authority currently has 138 families enrolled in the program.</i> • Establish Supportive Employment to augment the Family Self-Sufficiency program – <i>The Housing Authority established supportive employment and currently has 13 individuals enrolled in the program.</i> • Maintain compliance with all applicable program requirements – <i>There were no findings during the Housing Authority’s most recent audit for calendar year 2019.</i>
